## Restrictions

The Tufts Summer Reduced Tuition Program is a summer-only scholarship program at Tufts University. The reduction is for 50% off the tuition cost of the course. Administered by Tufts University Summer Session, students participating must enroll in courses offered by the School of Arts & Sciences or the School of Engineering on the Medford campus in the summer (Fletcher School courses do not apply). It is available to all employed, full-time teachers and occupational therapists. Professionals need not live or be employed in the greater Boston area.

- This program is not available to persons currently enrolled in a Tufts University degree program. This includes students who will enroll in a degree program in the next fall term (for example, fall 2009).
- Applicants must verify full-time employment at a public or private school, agency, or occupational therapy practice. Normally, this verification is provided by a principal, director, or human resources manager.
- It is assumed that all applicants will have earned a bachelor's degree from an accredited institution of higher education. If this is not the case, you must notify the Manager of Tufts University Summer Session in writing.
- Applicants must meet all course enrollment prerequisites and should verify with the instructor their suitability for the intended course or courses prior to enrollment. Discovery of prerequisite insufficiencies will not provide the basis for withdrawal or tuition refund.
- Participants may apply the benefit to one academic credit bearing course per summer session (12-Week courses count as first session courses), for a total of two credit bearing courses in one calendar summer.
- Late registration fees (\$50 or \$100) do apply.
- The discovery of false or erroneous information on the application will result in the retraction of the tuition reduction and the application of full tuition charges for the course or courses. No withdrawal will be allowed.
- The Manager of Tufts Summer Session is the university official who approves the awarding of the reduced tuition benefit. The Manager adjudicates all issues related to eligibility.
